There can be no assurance that our net cash flows shall be positive in the future. Any negative cash flows in the future over extended periods, or significant negative cash flows in the short term, could materially impact our ability to operate our business and implement our growth plans. As a result, our cash flows, business, future financial performance and results of operations could be materially and adversely affected. - Our Registered Office cum Showroom at Sowcarpet and our showroom at Kilpauk are not owned by us. Any inability to continue occupying these premises may adversely affect our business, financial condition and results of operations.***

Our Registered Office cum Showroom at Sowcarpet and our showroom at Kilpauk operate from leased premises. While these arrangements currently support our operations, there can be no assurance that the respective lease agreements will be renewed upon expiry or that alternative premises will be available on commercially acceptable terms.

In the event that any of these lease arrangements are terminated, not renewed, or otherwise become unavailable, we may be required to relocate our operations and incur additional costs towards identifying, securing and establishing alternative premises. Such relocation may result in operational disruptions, loss of customer footfall, interruption of business activities and diversion of management resources. Further, there can be no assurance that any alternative location would provide similar commercial advantages, accessibility or customer reach as our existing premises.

**3. *Our business is exposed to fluctuations in gold prices and changes in customer preferences, which may adversely affect our business, financial condition and results of operations.***

Our business is significantly influenced by fluctuations in gold prices and changing consumer preferences. Gold is a key raw material for our products, and any significant increase in gold prices may increase our procurement costs and reduce demand for gold jewellery, while any sharp decline in gold prices may adversely affect the value of our inventory and impact profitability.

Further, customer preferences in the jewellery industry are continuously evolving due to changes in fashion trends, purchasing behaviour and market dynamics. Our ability to maintain growth depends on our ability to anticipate and respond to such changes through appropriate product offerings and pricing strategies. Failure to accurately assess market trends or adapt to changing customer preferences may result in reduced demand, slow-moving inventory, lower sales and increased inventory holding costs.

Accordingly, any adverse movements in gold prices or inability to respond effectively to changing customer preferences may have a material adverse effect on our business, financial condition and results of operations.

**4. *Our business is substantially concentrated in Tamil Nadu, and any adverse developments in this region may have a material adverse effect on our business, financial condition and results of operations.***

Our business operations and revenue are predominantly concentrated in the state of Tamil Nadu. Revenue generated from Tamil Nadu amounted to ₹11,163.04 lakh and ₹5,822.33 lakh during Fiscal 2026 and Fiscal 2025 respectively, representing 97.78% and 97.66% of our total revenue from operations. As a result, our business is significantly exposed to economic, political, regulatory and market conditions prevailing in Tamil Nadu.

Any adverse developments in the region, including economic slowdowns, changes in consumer demand, increased competition, labour disruptions, natural calamities, public health emergencies, civil unrest or adverse changes in state government policies, may adversely affect our operations and financial performance. Further, our ability to reduce geographic concentration risks depends on our successful expansion into other states. Any inability to expand our presence beyond Tamil Nadu may limit our growth opportunities and could have a material adverse effect on our business, financial condition and results of operations.

**5. *Our inability to identify market trends, and customer demand accurately, counter the challenges that the industry faces and maintain an optimal level of inventory may impact our operations adversely.***

The growth and success of our business are substantially dependent on our ability to accurately anticipate market trends, assess customer demand, and align our product offerings accordingly. Given that our operations are primarily concentrated in Tamil Nadu, precise forecasting assumes critical importance. Any miscalculation in assessing customer preferences or demand patterns may have adverse consequences. An overestimation of demand could result in excess inventory, leading to increased carrying costs and potential obsolescence of stock due to rapidly changing jewellery trends and designs. Conversely, underestimation of demand may result in inadequate inventory levels, thereby restricting our ability to service customer requirements in a timely manner, which could lead to loss of customers, missed business opportunities, and adverse impact on our reputation in the market.

Maintaining an optimal level of inventory is therefore vital to our business, as it ensures responsiveness to customer demand while simultaneously supporting cost efficiency and operational effectiveness. However, this process is subject to inherent challenges arising from fluctuations in gold prices, dynamic consumer preferences, and our significant geographic concentration in a limited number of states. Any inability to effectively forecast demand, adapt to evolving customer preferences, or manage inventory at an optimal level could materially and adversely affect our business operations, financial performance, and long-term growth prospects.

6. ***We derive a significant portion of our revenue from the sale of gold jewellery, and any reduction in demand for such products may adversely affect our business, financial condition and results of operations.***

A substantial portion of our revenue is derived from the sale of gold jewellery. Revenue from gold jewellery sales amounted to ₹8,800.47 lakh and ₹5,827.50 lakh during Fiscal 2026 and Fiscal 2025, respectively, representing 77.09% and 97.74% of our total revenue from operations. Accordingly, our business and profitability are significantly dependent on the demand for gold jewellery.

Any decline in consumer demand for gold jewellery due to fluctuations in gold prices, changes in customer preferences, economic downturns, increased competition, changes in regulatory policies or other industry-specific factors may adversely affect our sales and profitability. Further, any disruption in the procurement of gold or other raw materials required for manufacturing and trading of gold jewellery may impact our ability to meet customer demand.

As a result of our significant dependence on gold jewellery sales, any adverse development affecting this product category could have a material adverse effect on our business, financial condition and results of operations.

7. ***We operate in a highly competitive industry, and our inability to compete effectively may adversely affect our business, financial condition and results of operations.***

The Indian jewellery industry is highly competitive and fragmented, comprising organized retail chains, regional jewellers, local jewellery stores and online platforms. We face competition on various factors including product quality, design, pricing, customer service, brand recognition and customer relationships. Certain competitors may have greater financial resources, larger retail networks, stronger brand presence and wider product offerings than us, enabling them to attract customers and gain market share.

Intense competition may result in pricing pressures, loss of customers, reduced sales volumes and increased marketing and customer acquisition costs. Further, the growth of organized jewellery retailers and omnichannel business models may require us to make additional investments in marketing, technology and retail expansion to remain competitive. Any inability to effectively compete, adapt to changing customer preferences or respond to evolving industry trends may have a material adverse effect on our business, financial condition and results of operations.

8. ***Our business is significantly dependent on our Sowcarpet showroom, and any disruption at this location could materially adversely affect our business, financial condition and results of operations.***

We currently operate two showrooms, one located at Sowcarpet, which also serves as our registered office, and another located at Kilpauk. A substantial portion of our revenue is generated from the Sowcarpet showroom. During Fiscal 2026 and Fiscal 2025, the Sowcarpet showroom contributed revenue of ₹10,278.58 lakh and ₹5,283.12 lakh, respectively, representing 90.04% and 88.62% of our total revenue from operations. In comparison, the Kilpauk showroom contributed ₹1,137.54 lakh and ₹678.69 lakh, respectively, representing 9.96% and 11.38% of our total revenue from operations.

Our significant dependence on a single showroom location exposes us to risks arising from business interruptions, natural calamities, fire, accidents, labour disruptions, regulatory actions, lease-related issues, infrastructure failures, security incidents or any other unforeseen events affecting the Sowcarpet showroom. Any disruption, temporary closure, reduced customer footfall or inability to operate from this location could materially impact our sales and profitability.

Accordingly, any adverse development affecting the operations of our Sowcarpet showroom may have a material adverse effect on our business, financial condition and results of operations.

9. ***Our business is significantly dependent on the B2B segment, and any adverse developments affecting this segment may have a material adverse effect on our business, financial condition and results of operations.***

Our revenue is predominantly derived from the B2B segment, comprising sales to wholesalers, small retailers and local jewellery shop owners. Revenue from the B2B segment was ₹9,940.68 lakh and ₹4,561.93 lakh during Fiscal

2026 and Fiscal 2025, respectively, representing 87.08% and 76.52% of our total revenue from operations. The significant contribution of the B2B segment to our revenue makes us dependent on the demand and purchasing patterns of our wholesale and trade customers.

Our business is exposed to risks associated with changes in market demand, customer preferences, pricing pressures, credit risks, increased competition and adverse developments affecting the wholesale jewellery trade. Any reduction in orders from our B2B customers, loss of key customers, inability to attract new customers, or slowdown in the jewellery industry could adversely impact our revenue and profitability.

Further, revenue from the B2C segment was ₹1,475.44 lakh and ₹1,399.88 lakh during Fiscal 2026 and Fiscal 2025, respectively, representing a relatively limited contribution to our overall revenue. As a result, our ability to diversify our revenue streams through direct consumer sales remains limited. Although we intend to expand our retail presence and strengthen our B2C operations, there can be no assurance that such initiatives will be successfully implemented or generate the expected benefits. Any inability to diversify our revenue base or sustain growth in the B2B segment may have a material adverse effect on our business, financial condition and results of operations.

10. ***We derive a substantial portion of our revenue from a limited number of customers and do not have long-term contracts with them. The loss of any key customer or a reduction in orders from such customers could adversely affect our business, financial condition and results of operations.***

We derive a significant portion of our revenue from a limited number of customers. During Fiscal 2026, our top 1, top 5 and top 10 customers contributed ₹5,039.27 lakh (44.14%), ₹9,297.76 lakh (81.44%) and ₹9,790.83 lakh (85.76%) of our revenue from operations, respectively. During Fiscal 2025, our top 1, top 5 and top 10 customers contributed ₹4,238.54 lakh (71.06%), ₹4,427.88 lakh (74.23%) and ₹4,532.64 lakh (75.99%) of our revenue from operations, respectively.

Our Company generally does not enter into long-term contracts with its customers and primarily relies on purchase orders. Such orders may be cancelled, modified, delayed or reduced, and customers may change their sourcing strategies at any time. As a result, we have limited visibility on future order volumes and revenues.

Any loss of a key customer, reduction in orders, inability to retain existing customers or attract new customers, or any adverse change in customer purchasing patterns could materially and adversely affect our business, financial condition and results of operations.

11. ***Our business is dependent on third-party manufacturers for the production of jewellery products, and any disruption in such arrangements may adversely affect our business, financial condition and results of operations.***

Our Company is engaged in the sale of jewellery products through trading and outsourced manufacturing arrangements and does not own or operate any in-house manufacturing facility. We rely on third-party manufacturers and artisans for the production of our jewellery products and are therefore dependent on their production capabilities, quality standards, operational efficiency and financial stability.

Any delay in production, failure to meet quality specifications, non-compliance with applicable laws and regulations, labour shortages, capacity constraints, disruption in the supply chain, or termination of relationships with such manufacturers may adversely affect our ability to procure products and fulfil customer orders in a timely manner. Further, as the manufacturing process is undertaken by third parties, we have limited control over their manufacturing practices, quality control systems and operational processes.

In addition, any increase in manufacturing charges, shortage of skilled craftsmen, inability to engage alternative manufacturers on commercially acceptable terms, or adverse developments affecting our manufacturing partners may increase our operating costs and adversely impact our margins and profitability. Any product defects, quality issues or delays attributable to third-party manufacturers may also adversely affect our reputation and customer relationships.

Accordingly, any disruption in our outsourced manufacturing arrangements may have a material adverse effect on our business, financial condition, results of operations and future growth prospects.

12. ***Our business is dependent on a limited number of suppliers, and the loss of one or more key suppliers or any disruption in the supply of raw materials may adversely affect our business, financial condition and results of operations.***

We depend on a limited number of suppliers for the procurement of raw materials required for our business operations. During Fiscal 2026, our top 1, top 5 and top 10 suppliers accounted for ₹3,105.96 lakh (26.70%), ₹7,638.42 lakh (65.66%) and ₹9,991.06 lakh (85.88%) of our total purchases, respectively. During Fiscal 2025, our top 1, top 5 and top 10 suppliers accounted for ₹1,501.88 lakh (25.99%), ₹4,362.60 lakh (75.49%) and ₹4,722.06 lakh (81.71%) of our total purchases, respectively.

Our dependence on a limited number of suppliers exposes us to risks relating to supply disruptions, delays in procurement, shortages of raw materials, changes in supplier pricing policies, deterioration in supplier relationships or the loss of key suppliers. Any inability to procure raw materials in a timely manner, on commercially acceptable terms or in sufficient quantities may disrupt our operations and adversely affect our ability to meet customer requirements.

Accordingly, the loss of one or more significant suppliers or any material disruption in our supply chain could have a material adverse effect on our business, financial condition and results of operations.

13. ***Our business is working capital intensive, and any inability to meet our working capital requirements may adversely affect our business, financial condition and results of operations.***

Our business requires significant working capital to finance inventory, procure bullion, make payments to third-party manufacturers and support trade receivables. As of March 31, 2026 and March 31, 2025, our inventories amounted to ₹2,930.66 lakh and ₹2,070.37 lakh, respectively, while trade receivables stood at ₹436.20 lakh and ₹100.71 lakh, respectively. Accordingly, a substantial portion of our working capital is deployed towards inventories and receivables.

The jewellery business is inherently working capital intensive, and our continued growth depends on the availability of adequate funding on commercially acceptable terms. We rely on internal accruals and external borrowings, including working capital facilities, to meet our operational requirements. Any reduction in the availability of such financing, increase in borrowing costs, delays in collection of receivables, or inability to efficiently manage inventory levels may result in liquidity constraints and adversely affect our ability to procure materials, fulfil customer orders and expand our business.

Any inability to adequately fund our working capital requirements could have a material adverse effect on our business, financial condition, cash flows and results of operations.

14. ***Our business is subject to seasonal fluctuations, and lower-than-expected sales during peak seasons may adversely affect our business, financial condition and results of operations.***

Our business is influenced by seasonal factors, including festivals, wedding seasons and other auspicious occasions, during which demand for jewellery products generally increases. As a result, a significant portion of our revenue is generated during such peak periods.

Any reduction in customer demand during these periods due to adverse economic conditions, fluctuations in gold prices, changes in consumer preferences, reduced discretionary spending, regulatory changes or other unforeseen factors may adversely affect our revenues and profitability. Further, our inability to effectively manage inventory levels, working capital requirements and other operational resources in anticipation of seasonal demand may result in excess inventory, increased costs or missed sales opportunities.

Accordingly, lower-than-expected sales during peak seasons may have a disproportionate impact on our business, financial condition, cash flows and results of operations.

15. ***We operate in a high-value commodity sector and are exposed to risks associated with the storage, transit and delivery of jewellery products, including theft, loss, damage and fraud.***

Our business involves the handling, storage and transportation of gold jewellery and other precious products, which are high-value and portable in nature. As a result, we are exposed to risks of theft, loss, damage, misappropriation, fraud, shoplifting and other security-related incidents during storage, transit or delivery. Any such incident may result in financial losses, inventory shortages, business disruptions and reputational damage.

Although we have implemented various security measures, including CCTV surveillance, security personnel and engagement of specialized logistics service providers, there can be no assurance that such measures will be sufficient to prevent all security breaches or losses. Further, we may be exposed to risks arising from employee misconduct, vendor-related fraud, operational errors or criminal activities by third parties.

Any significant loss, theft, damage or security breach involving our products could adversely affect customer confidence, increase operating costs and have a material adverse effect on our business, financial condition and results of operations.

16. ***Our insurance coverage may not be adequate to protect us against all losses, and any uninsured or underinsured loss may adversely affect our business, financial condition and results of operations.***

We maintain insurance coverage for certain risks associated with our business, including coverage for inventory, and transit-related risks. While we believe that our existing insurance policies are adequate for our current operations, there can be no assurance that such coverage will be sufficient to protect us against all potential losses or that claims made under these policies will be settled in a timely manner or at all.

Certain risks may not be adequately insured, may be excluded from coverage, or may exceed the limits of our insurance policies. In the event of any significant loss, damage, theft, accident, natural calamity or other unforeseen event, we may be required to bear a portion of the losses ourselves. Further, any delay or denial of insurance claims could adversely impact our cash flows and operations.

Accordingly, any uninsured, underinsured or inadequately compensated loss may have a material adverse effect on our business, financial condition and results of operations.

17. ***Our ability to protect and enforce our intellectual property rights is limited, and any failure to obtain or maintain protection for our trademarks may adversely affect our business, financial condition and results of operations.***

We have applied for registration of our trademarks of “” and “” with application number being 7429015 and 7738854 respectively under Class – 14 for registration of the same under the Trade Marks Act, 1999. However, as of the date of this Letter of Offer, the registrations have not yet been granted and the applications are pending with the status of “Formalities Chk Pass”. Accordingly, we do not currently enjoy the full statutory protection available to registered trademark owners in respect of such marks.

There can be no assurance that our trademark applications will ultimately be registered or that third parties will not challenge, oppose or infringe upon our intellectual property rights. Further, we may not be able to detect or prevent unauthorized use of our trademarks or take timely and effective action to enforce our rights. Any failure to obtain registration, protect our trademarks, or prevent their unauthorized use may dilute our brand value, affect our reputation and adversely impact our business, financial condition and results of operations.

18. ***Jewellery purchases are discretionary in nature, and any reduction in consumer spending may adversely affect our business, financial condition and results of operations.***

Demand for jewellery products is largely dependent on consumers' discretionary spending power, disposable income and overall economic sentiment. Jewellery purchases are influenced by various factors, including economic conditions, inflation, interest rates, employment levels, availability of consumer credit, consumer confidence, and fluctuations in the prices of gold and other precious metals. In addition, demand for jewellery is often linked to wedding seasons, festivals and other cultural occasions.

As jewellery is generally considered a discretionary purchase, any economic slowdown, reduction in disposable income, adverse changes in consumer preferences, volatility in gold prices, or uncertainty in domestic or global markets may lead consumers to defer or reduce jewellery purchases. Such factors could result in lower customer demand, reduced sales and lower profitability.

Accordingly, any decline in consumer discretionary spending or adverse changes in economic and market conditions may have a material adverse effect on our business, financial condition and results of operations.

**19. *Any failure to maintain product quality, authenticity and compliance with BIS hallmarking and HUID requirements may adversely affect our business, financial condition and results of operations.***

Our business is dependent on maintaining the quality, purity and authenticity of the jewellery products sold by us, as well as complying with applicable regulatory requirements relating to hallmarking and Hallmark Unique Identification ("HUID") prescribed by the Bureau of Indian Standards ("BIS"). Despite our quality control procedures, there may be instances of variation in purity, design, finishing, hallmarking or HUID tagging due to human error, manufacturing defects or operational lapses.

Any discrepancies relating to product quality, authenticity, hallmarking or HUID compliance may result in customer complaints, product returns, replacements, regulatory scrutiny, penalties, confiscation of goods, reputational damage and loss of customer confidence. Further, as we expand our operations and product offerings, ensuring compliance with evolving BIS regulations may increase operational complexity and compliance costs. Any changes in applicable regulations or failure to comply with such requirements could adversely affect our ability to sell certain products and maintain customer trust.

Accordingly, any product quality issues, authenticity disputes or non-compliance with BIS hallmarking and HUID requirements may have a material adverse effect on our business, financial condition, results of operations and prospects.

**20. *Our future growth and profitability depend on the successful implementation of our business strategies, and any failure to effectively execute such strategies may adversely affect our business, financial condition and results of operations.***

Our future growth depends on our ability to successfully implement our business strategies, including expanding our retail presence, increasing our customer base, strengthening our product portfolio and enhancing our market position. While we have successfully executed our strategies in the past, there can be no assurance that we will be able to continue to do so within the anticipated timelines, costs or expected outcomes.

The implementation of our business strategies is subject to various risks, including changes in market conditions, customer preferences, competitive pressures, availability of financial resources, operational challenges and changes in applicable laws and regulations. Any delay, inability or failure to effectively execute our strategic initiatives may limit our growth opportunities, increase costs and adversely affect our ability to achieve our business objectives.

Accordingly, any failure to successfully implement our business strategies may have a material adverse effect on our business, financial condition and results of operations.

**21. *Adverse economic and market conditions in India or globally may have a material adverse effect on our business, financial condition and results of operations.***

Our business is influenced by general economic, political and market conditions in India, as well as developments in the global economy. Factors such as economic growth, inflation, interest rates, currency fluctuations, consumer confidence, employment levels, taxation policies, availability of credit, government regulations and overall business sentiment may affect consumer spending and demand for jewellery products.

The jewellery industry is particularly sensitive to changes in disposable income, purchasing behaviour and investment preferences. Any economic slowdown, persistent inflation, reduction in consumer spending, volatility

in gold prices, adverse changes in financial markets or geopolitical uncertainties may negatively impact demand for our products and affect our revenue and profitability.

Further, adverse global economic conditions may indirectly impact the Indian economy and consumer sentiment. Accordingly, any deterioration in economic or market conditions in India or internationally could have a material adverse effect on our business, financial condition, cash flows and results of operations.

**22. *As a listed company, our Company is subject to certain obligations and reporting requirements under the SEBI Listing Regulations, and we must comply with other SEBI regulations as may be applicable to us.***

Our Company got listed on the BSE (SME) Platform on 12th May, 2025; therefore, we are subject to the obligations and reporting requirements prescribed under the SEBI (LODR) Regulations to the extent applicable, and have to adhere to and comply with other applicable Regulations framed by SEBI. Our Company endeavours to comply with all such obligations and reporting requirements, any non-compliance which might have been committed by us, may result into Stock Exchange and/or SEBI imposing penalties, issuing warnings and show cause notices against us and/or taking actions as provided under the SEBI Act and the rules and regulations made there under and applicable SEBI Circulars. There were 2 instances of non-compliance by the Company since its listing wherein it made delayed submissions upon getting listed on SME Platform of BSE Limited. These instances of non-compliance may have exposed it to increased scrutiny by the stock exchange. There can be no assurance that our Company will always be able to comply with all regulatory and disclosure requirements in a timely manner in the future. Any further delay, default, or non-compliance may result in additional monetary penalties, restrictions on certain corporate actions, or other disciplinary measures by the regulators. Such actions could adversely affect our reputation, investor confidence, ability to raise capital in the future, and overall business operations. For further details, please refer, chapter titled "Other Regulatory and Statutory Disclosures" under the section "Compliance with the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015" on Page 59 of this Draft Letter of Offer.

**23. *Our business is subject to various statutory and regulatory approvals, licences and registrations, and any failure to obtain, maintain or renew such approvals may adversely affect our business, financial condition and results of operations.***

Our business is subject to various laws and regulations, and we are required to obtain and maintain certain licences, registrations, permits and approvals for the conduct of our operations. Such approvals are subject to conditions and may require periodic renewals, compliance filings and ongoing adherence to applicable regulatory requirements.

There can be no assurance that all existing approvals will continue to remain valid, or that any approvals, licences or registrations applied for by us will be granted, renewed or maintained in a timely manner or on commercially acceptable terms. Any failure to obtain, renew or comply with the conditions of such approvals may result in penalties, suspension, cancellation or revocation of the relevant licences and permits, which could disrupt our operations.

Accordingly, any inability to obtain, maintain or renew the necessary regulatory approvals, licences and registrations required for our business may have a material adverse effect on our business, financial condition and results of operations.

**24. *We have not declared any dividends in the past, and our ability to pay dividends in the future will depend on our future earnings, financial condition and cash flows.***

Since our incorporation, we have not declared any dividends on our Equity Shares. We may continue to retain our earnings, if any, to finance the growth and expansion of our business, meet working capital requirements and support future operations. Consequently, there can be no assurance that we will declare or pay dividends in the foreseeable future.

Any future declaration and payment of dividends will be subject to the discretion of our Board of Directors and shareholders, as applicable, and will depend on various factors, including our profitability, financial condition, cash flows, capital expenditure requirements, working capital needs, business prospects, contractual restrictions and applicable legal requirements.

As a result, investors may need to rely primarily on appreciation in the market price of our Equity Shares for a return on their investment. There can be no assurance that our Equity Shares will appreciate in value or that any dividends will be declared in the future. Accordingly, our inability to pay dividends may adversely affect the market price of our Equity Shares.

**25. *Any failure to protect customer data, payment information or other confidential information may adversely affect our business, reputation, financial condition and results of operations.***

Our business involves the collection, processing and transmission of customer and employee information, including personal and payment-related data through electronic payment methods such as credit cards, debit cards and digital payment platforms. As a result, we are exposed to risks associated with cyberattacks, data breaches, unauthorized access, system failures, employee misconduct and other security incidents.

Although we have implemented various security measures and do not store customers' credit or debit card information, there can be no assurance that our systems, or those of our third-party service providers, will not be compromised. Any actual or perceived breach of data security may result in loss of confidential information, disruption of operations, customer claims, regulatory investigations, litigation, penalties and increased compliance costs.

Further, data protection and privacy laws are evolving and becoming increasingly stringent. Any failure to comply with applicable data protection requirements or adequately safeguard customer information may result in reputational damage, loss of customer confidence and financial liabilities. Accordingly, any significant data security incident or cyberattack could have a material adverse effect on our business, financial condition and results of operations.

**26. *Our success depends on our ability to maintain and enhance our brand recognition, and any failure to do so may adversely affect our business, financial condition and results of operations.***

Our brand and reputation are important factors in attracting and retaining customers and supporting the growth of our business. The jewellery industry is highly competitive, and customers often make purchasing decisions based on factors such as brand recognition, trust, product quality and customer experience. Accordingly, our ability to maintain and strengthen our brand image is critical to our continued success.

We may be required to incur significant expenditure on marketing, promotional activities, customer engagement initiatives and other brand-building efforts. However, there can be no assurance that such initiatives will be successful or cost-effective in enhancing customer awareness or expanding our customer base. Further, any negative publicity, customer dissatisfaction, product quality concerns or adverse events affecting our reputation may diminish the value of our brand.

Any inability to maintain, protect or enhance our brand recognition and reputation could adversely affect customer demand for our products and have a material adverse effect on our business, financial condition and results of operations.

**27. *Our existing indebtedness, dependence on external financing for working capital requirements and obligations under financing arrangements may adversely affect our business, financial condition and results of operations.***

Our business is working capital intensive and requires substantial funding for the procurement of inventory, maintenance of stock levels and day-to-day operations. We have incurred indebtedness in the ordinary course of business to finance our operations and working capital requirements and may require additional borrowings in the future to support our growth plans and business expansion.

Our ability to service existing and future indebtedness depends on our cash flows, profitability and overall financial performance. Any deterioration in our operating performance, liquidity position or ability to generate sufficient cash flows may impair our ability to meet principal and interest obligations as they become due. Further, we have not made any alternative arrangements for meeting our working capital requirements other than our existing sanctioned credit facilities. Any inability to obtain additional funding, renew existing facilities, or secure financing

on commercially acceptable terms may adversely affect our ability to procure inventory, meet operational requirements and implement our growth strategies.

In addition, our financing arrangements contain certain financial and other restrictive covenants that limit our operational and financial flexibility and require compliance with specified conditions. Any breach of such covenants or failure to comply with the terms of our financing arrangements may result in penal interest, suspension or termination of facilities, acceleration of repayment obligations, enforcement of security interests and triggering of cross-default provisions under other financing arrangements. Our borrowings are secured against certain assets of the Company, and any enforcement of such security may adversely affect our operations.

Accordingly, any inability to obtain adequate funding, service our indebtedness or comply with the terms of our financing arrangements may have a material adverse effect on our business, financial condition and results of operations.

**28. *Our Promoters have provided personal guarantees in connection with certain borrowings availed by our Company and any invocation, withdrawal or enforcement of such guarantees may adversely affect our business, financial condition and prospects.***

Certain of our borrowings are supported by personal guarantees provided by our Promoters and Directors. In the event of any default under the relevant financing arrangements, lenders may invoke such guarantees, which could adversely affect the reputation of our Company and our Promoters. Further, any enforcement action against our Promoters may affect their ability to devote time and resources towards the management of our Company.

In addition, if our Promoters are required to discharge obligations under such guarantees, they may be compelled to liquidate a portion of their shareholding in our Company, which could result in a reduction of promoter shareholding. Further, if any such guarantees are withdrawn or cease to be available and we are unable to provide alternative security or guarantees acceptable to lenders, we may be required to repay the relevant borrowings, furnish additional collateral or arrange alternative financing, which may not be available on favourable terms or at all.

## **RISKS RELATING TO RIGHTS ISSUE AND OBJECTS OF THE ISSUE**

**1. *A Substantial Portion of the Net Proceeds from the Rights Issue Is Proposed to Be Utilized for Working Capital Requirements, and Any Inefficient Deployment or Variation in These Requirements May Adversely Affect Our Liquidity, Operations, and Financial Performance.***

Our Company proposes to allocate approximately ₹ 1,353.23 lakhs, representing a substantial portion of the Net Proceeds from the Rights Issue, towards meeting its working capital requirements. Working capital is essential for supporting day-to-day operations, including financing inventory, trade receivables, other current assets, trade payables, and short-term financial obligations. The quantum and deployment of working capital are inherently dynamic and influenced by several factors such as business growth, operational costs, customer credit cycles, market conditions, and seasonality in demand.

Unlike investments in fixed assets, the working capital cycle is continuously revolving, and therefore, monitoring and effectively managing its utilization poses ongoing operational challenges. Any inefficiency, diversion, or delay in deployment of the working capital funds could strain our liquidity, disrupt operations, and adversely affect our cash flows and profitability. Furthermore, the actual working capital requirements may differ from current estimates due to changes in our business operations, market fluctuations, or external economic factors.

In the event of any shortfall, our Company may need to seek additional financing through borrowings or other sources, which could increase our financial costs and affect our overall financial position. The proposed utilization of the Net Proceeds is based on management's current business plans, internal estimates, and prevailing market conditions. However, these assumptions are subject to change due to factors beyond our control, including market volatility, competitive pressures, and macroeconomic developments. Consequently, our management may, at its discretion and in accordance with applicable laws, revise or reschedule the proposed deployment of funds. Any such change could have an adverse impact on our business operations, liquidity position, and financial condition.

**2. *Our Promoters have expressed their intention to subscribe up to an extent of 17% of its rights entitlement.***

Our Promoters have confirmed their intention to subscribe up to an extent of 17% of its respective Rights Entitlement in this Rights Issue. They have further undertaken to subscribe to such portion of the Rights Equity Shares that remain unsubscribed to the extent of minimum subscription i.e., 90% of the total issue size, after considering all valid applications, including additional applications from public shareholders, subject to compliance with the minimum public shareholding requirements under Regulation 38 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. Accordingly, for the Rights Issue to be fully subscribed without triggering additional subscription by the Promoter, the public shareholders will need to (i) fully subscribe to their Rights Entitlement and (ii) apply for additional Rights Equity Shares. In the event of under-subscription by public shareholders, the unsubscribed portion will be allocated to the Promoter and Promoter Group as per their undertaking. Although our Promoter is obligated to subscribe to the unsubscribed portion to the extent of minimum subscription criteria of 90% of the total issue size, its limited participation in its own Rights Entitlement may be perceived negatively by investors and could impact overall investor sentiment. There can be no assurance that public shareholders will subscribe to their full entitlements. Any such perception or shortfall in public participation may affect the market performance of our Equity Shares and could have an adverse effect on our reputation and investor confidence.

**3. *If our Company does not receive the minimum subscription of 90% of the total Issue Size, the Issue may fail.***

In the event our Company does not receive the minimum subscription of 90% of the total Issue Size or the subscription level falls below 90% of the total Issue Size after the Issue Closing Date on account of withdrawal of Applications or technical rejections or any other reason, our Company shall refund the entire subscription amount received not later than four days from the closure of the Rights Issue or any other period as may be prescribed under applicable law. In the event there is a delay in making a refund of the subscription monies, our Company shall be required to pay interest for the delayed period at such a rate prescribed under applicable law. ***The Objects of the Issue for which funds are being raised, are based on our management estimates and any bank or financial institution or any independent agency has not appraised the same. The deployment of funds in the project is entirely at our discretion, based on the parameters as mentioned in the chapter titled “Objects of the Issue”.*** The fund requirement and deployment, as mentioned in the “Objects of the Issue” on page 42 of this Letter of Offer is based on the estimates of our management and has not been appraised by any bank or financial institution or any other independent agency. These fund requirements are based on our current business plan.

We cannot assure that the current business plan will be implemented in its entirety or at all. In view of the highly competitive and dynamic nature of our business, we may have to revise our business plan from time to time and consequently these fund requirements. The deployment of the funds as stated under chapter “Objects of the Issue” beginning at page 42, is at the discretion of our Board of Directors and is subject to monitoring by external independent agency. Further, we cannot assure that the actual costs or schedule of implementation as stated under chapter Objects of the Issue will not vary from the estimated costs or schedule of implementation. Any such variance may be on account of one or more factors, some of which may be beyond our control. Occurrence of any such event may delay our business plans and/or may have an adverse bearing on our expected revenues and earnings.

**4. *The Rights Entitlement of Eligible Equity Shareholders holding Equity Shares in physical form may lapse in case they fail to furnish the details of their demat account to the Registrar.***

In accordance with Regulation 77A of the SEBI ICDR Regulations read with the SEBI ICDR Master Circular, the credit of Rights Entitlements and Allotment of Rights Equity Shares shall be made in dematerialized form only. Prior to the Issue Opening Date, our Company shall credit the Rights Entitlements to the demat accounts of the Eligible Equity Shareholders holding the Equity Shares in dematerialized form.

Our Company has opened a separate demat suspense escrow account (namely, “**MANOJ JEWELLERS LIMITED**”) and would credit Rights Entitlements on the basis of the Equity Shares: (a) held by Eligible Equity Shareholders which are held in physical form as on Record Date; or (b) which are held in the account of the Investor Education and Protection Fund (“**IEPF**”) authority; or which of the Eligible Equity Shareholder whose demat accounts are frozen or where the Equity Shares are lying in the unclaimed/ suspense escrow account / demat suspense account (including those pursuant to Regulation 39 of the SEBI LODR Regulations) or details of which are unavailable with our Company or with the Registrar on the Record Date or where Equity Shares have been kept in abeyance or where entitlement certificate has been issued or where instruction has been issued for stopping issue or transfer or where letter of confirmation lying in escrow account; or (d) where credit of the Rights Entitlements have returned/reversed/failed for any reason; or (e) where ownership is currently under dispute, including any court

or regulatory proceedings or where legal notices have been issued, if any or (f) such other cases where our Company is unable to credit Rights Entitlements for any other reasons.

Our Company shall credit the Rights Entitlements to the Demat Suspense Account on the basis of information available with our Company and to serve the interest of relevant Eligible Equity Shareholders to provide them with a reasonable opportunity to participate in the Issue. The credit of the Rights Entitlements to the Demat Suspense Account by our Company does not create any right in favour of the relevant Eligible Equity Shareholders for transfer of Rights Entitlement to their demat account or to receive any Equity Shares in the Issue.

With respect to the Rights Entitlements credited to the Demat Suspense Account, the Eligible Equity Shareholders are required to provide relevant details / documents as acceptable to our Company or the Registrar (such as applicable regulatory approvals, self-attested PAN and client master sheet of demat account, details/ records confirming the legal and beneficial ownership of their respective Equity Shares, etc.) to our Company or the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable credit of their Rights Entitlements by way of transfer from the Demat Suspense Account to their demat account at least one day before the Issue Closing Date, to enable such Eligible Equity Shareholders to make an application in this Issue, and this communication shall serve as an intimation to such Eligible Equity Shareholders in this regard. In the event that the Eligible Equity Shareholders are not able to provide relevant details to our Company or the Registrar by the end of two clear Working Days prior to the Issue Closing Date, Rights Entitlements credited to the Demat Suspense Account shall lapse and extinguish in due course and such Eligible Equity Shareholder shall not have any claim against our Company and our Company shall not be liable to any such Eligible Equity Shareholder in any form or manner and such lapsing of Rights Entitlement may dilute and adverse impact the interest of certain Eligible Equity Shareholders. For details, please see “*Terms of the Issue*” on page 63.

**5. *The Eligible Equity Shareholders holding Equity Shares in physical form will have no voting rights in respect of Rights Equity Shares until they provide details of their demat account and Rights Equity Shares are transferred to such demat account from the demat suspense account thereafter.***

In accordance with the SEBI ICDR Master Circular, the credit of Rights Entitlement and Allotment of Equity Shares shall be made in dematerialized form only. Accordingly, the Rights Entitlements of the Physical Shareholders shall be credited in a suspense escrow demat account opened by our Company during the Issue Period. The Physical Shareholders are requested to furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable the credit of their Rights Entitlements in their demat accounts at least one day before the Issue Closing Date. The Rights Entitlements of the Physical Shareholders who do not furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date, shall lapse. Further, pursuant to a press release dated December 3, 2018 issued by the SEBI, with effect from April 1, 2019, a transfer of listed Equity Shares cannot be processed unless the Equity Shares are held in dematerialized form (except in case of transmission or transposition of Equity Shares). For further information, see “*Terms of the Issue*” on page 63.

**6. *Applicants to this Issue are not allowed to withdraw their Applications after the Issue Closing Date.***

In terms of the SEBI ICDR Regulations, Applicants in this Issue are not allowed to withdraw their Applications after the Issue Closing Date. The Allotment in this Issue and the credit of such Rights Equity Shares to the Applicant’s demat account with its depository participant shall be completed within such period as prescribed under the applicable laws. There is no assurance, however, that material adverse changes in the international or national monetary, financial, political or economic conditions or other events in the nature of force majeure, material adverse changes in our business, results of operations or financial condition, or other events affecting the Applicant’s decision to invest in the Rights Equity Shares, would not arise between the Issue Closing Date and the date of Allotment in this Issue. Occurrence of any such events after the Issue Closing Date could also impact the market price of our Equity Shares. The Applicants shall not have the right to withdraw their applications in the event of any such occurrence. We cannot assure you that the market price of our Equity Shares will not decline below the Issue Price. To the extent the market price for our Equity Shares declines below the Issue Price after the Issue Closing Date, the shareholder will be required to purchase Rights Equity Shares at a price that will be higher than the actual market price for the Equity Shares at that time. Should that occur, the shareholder will suffer an immediate unrealized loss as a result. We may complete the Allotment even if such events may limit the Applicants’ ability to sell our Equity Shares after this Issue or cause the trading price of our Equity Shares to decline.

**7. *Failure to exercise or sell the Rights Entitlements will cause the Rights Entitlements to lapse without compensation and result in a dilution of shareholding.***

Rights Entitlements that are not exercised prior to the end of the Issue Closing Date will expire and become null and void, and Eligible Equity Shareholders will not receive any consideration for them. The proportionate ownership and voting interest in our Company of Eligible Equity Shareholders who fail (or are not able) to exercise their Rights Entitlements will be diluted. Even if you elect to sell your unexercised Rights Entitlements, the consideration you receive for them may not be sufficient to fully compensate you for the dilution of your percentage ownership of the equity share capital of our Company that may be caused as a result of the Issue. Renouncees may not be able to apply in case of failure of completion of renunciation through off-market transfer in such a manner that the Rights Entitlements are credited to the demat account of the Renouncees prior to the Issue Closing Date. Further in case, the Rights Entitlements do not get credited in time, in case of On Market Renunciation, such Renouncee will not be able to apply in this Issue with respect to such Rights Entitlements. For details, see “*Terms of the Issue*” on page 63.

**8. *Our Company will not distribute the Letter of Offer and other Issue related materials to overseas shareholders who have not provided an address in India for service of documents.***

We will not distribute the Issue Material to the shareholders who have not provided an address in India for service of documents. The Issue Material will not be distributed to addresses outside India on account of restrictions that apply to circulation of such materials in various overseas jurisdictions. In the case that Eligible Equity Shareholders have provided their valid e-mail address, the Letter of Offer will be sent only to their valid e-mail address and in the case that such Eligible Equity Shareholders have not provided their e-mail address, then the Letter of Offer will be dispatched, on a reasonable effort basis, to the Indian addresses provided by them.

However, the Companies Act, 2013 requires companies to serve documents at any address which may be provided by the members as well as through e-mail. Presently, there is lack of clarity under the Companies Act, 2013 and the rules thereunder with respect to distribution of Issue Material in overseas jurisdictions where such distribution may be prohibited under the applicable laws of such jurisdiction. While our Company will request its shareholders to provide an address in India for the purposes of distribution of Issue Material, our Company cannot assure that the regulator would not adopt a different view with respect to compliance with the Companies Act, 2013 and may subject our Company to fines or penalties.

**9. *Overseas shareholders may not be able to participate in the Company’s future rights offerings or certain other equity issues.***

If our Company offers or causes to be offered to holders of its Equity Shares rights to subscribe for additional Equity Shares or any right of any other nature, our Company will have discretion as to the procedure to be followed in making such rights available to overseas holders of the Equity Shares or in disposing of such rights for the benefit of such holders. For instance, our Company may not offer such rights to the holders of Equity Shares who have a registered address in the United States unless: (i) a registration statement is in effect, if a registration statement under the U.S. Securities Act is required in order for the Company to offer such rights to holders and sell the securities represented by such rights; or (ii) the offering and sale of such rights or the underlying securities to such holders are exempt from registration under the provisions of the U.S. Securities Act. Our Company has no obligation to prepare or file any registration statement. Accordingly, shareholders who have a registered address in the United States may be unable to participate in future rights offerings and may experience a dilution in their holdings as a result.

**10. *Investors will be subject to market risks until our Equity Shares credited to the investor’s demat account are listed and permitted to trade.***

Investors can start trading the Rights Equity Shares Allotted to them only after they have been credited to an investor’s demat account, are listed and permitted to trade. Since our Equity Shares are currently traded on the BSE SME, investors will be subject to market risk from the date they pay for the Rights Equity Shares to the date when trading approval is granted for the same. Further, there can be no assurance that the Rights Equity Shares allocated to an investor will be credited to the investor’s demat account or that trading in such Equity Shares will commence in a timely manner.

**11. *Any future issuance of Equity Shares by our Company or sales of our Equity Shares by any of our Company’s significant shareholders may adversely affect the trading price of our Equity Shares.***

Any future issuance of Equity Shares by us could dilute your shareholding. Any such future issuance of our Equity Shares or sales of our Equity Shares by any of our significant shareholders may also adversely affect the trading price of our Equity Shares, and could impact our ability to raise capital through an offering of our securities. We cannot

assure you that we will not issue further equity shares or that the shareholders will not dispose of, pledge, or otherwise encumber their equity shares. In addition, any perception by investors that such issuances or sales might occur could also affect the trading price of our Equity Shares.

***12. The Rights Equity Shares may experience price and volume fluctuations.***

The market price of the Rights Equity Shares can be volatile as a result of several factors beyond our control, including volatility in the Indian and global securities markets, our results of operations, the performance of our competitors, developments in the Indian finance and lending sector, changing perceptions in the market about investments in this sector in India, investor perceptions of our future performance, adverse media reports about us or our sector, changes in the estimates of our performance or recommendations by financial analysts, significant developments in India's economic liberalization and deregulation policies, and significant developments in India's fiscal regulations. In addition, the stock exchange may experience significant price and volume fluctuations, which may have a material adverse effect on the market price of the Rights Equity Shares.

General or industry specific market conditions or stock performance or domestic or international macroeconomic and geopolitical factors unrelated to our performance also affect the price of the Rights Equity Shares. In particular, the stock market as a whole recently experienced extreme price and volume fluctuations that have affected the market price of many companies in ways that may have been unrelated to the companies' operating performances. For these reasons, investors should not rely on recent trends to predict future share prices, results of operations or cash flow and financial condition.

***13. No market for the Rights Entitlements may develop and the price of the Rights Entitlements may be volatile.***

No assurance can be given that an active trading market for the Rights Entitlements will develop on the Stock Exchange during the Renunciation Period or that there will be sufficient liquidity in Rights Entitlements trading during this period. The trading price of the Rights Entitlements will not only depend on supply and demand for the Rights Entitlements, which may be affected by factors unrelated to the trading in the Equity Shares, but also on the quoted price of the Equity Shares, amongst others. Factors affecting the volatility of the price of the Equity Shares, as described herein, may magnify the volatility of the trading price of the Rights Entitlements, and a decline in the price of the Equity Shares will have an adverse impact on the trading price of the Rights Entitlements. Since the trading of the Rights Equity Shares will be on a separate segment compared to the Equity Shares on the floor of the Stock Exchange, the trading of Rights Equity Shares may not track the trading of Equity Shares.

***14. Foreign investors are subject to foreign investment restrictions under Indian law that limit our Company's ability to attract foreign investors, which may adversely affect the market price of the Equity Shares.***

Under the foreign exchange regulations currently in force in India, transfers of shares between nonresidents and residents and issuances of shares to non-residents are freely permitted (subject to certain exceptions) if they comply with the requirements specified by the RBI. If such issuances or transfers of shares are not in compliance with such requirements or fall under any of the specified exceptions, then prior approval of the RBI will be required. We have undertaken or recorded such transactions in the past based on a bona fide interpretation of the law. We cannot assure you that our interpretation would be upheld by the Indian regulators. Any change in such interpretation could impact the ability of our Company to attract foreign investors.

In addition, shareholders who seek to convert the Indian Rupee proceeds from a sale of shares in India into foreign currency and repatriate that foreign currency from India will require a no-objection or tax clearance certificate from the income tax authority. Additionally, the Government of India may impose foreign exchange restrictions in certain emergency situations, including situations where there are sudden fluctuations in interest rates or exchange rates, where the Government of India experiences extreme difficulty in stabilizing the balance of payments, or where there are substantial disturbances in the financial and capital markets in India. These restrictions may require foreign investors to obtain the Government of India's approval before acquiring Indian securities or repatriating the interest or dividends from those securities or the proceeds from the sale of those securities. We cannot assure you that any approval required from the RBI or any other government agency can be obtained on any particular terms, or at all.

***15. Rights of shareholders under Indian law may differ or may be more limited than under the laws of other jurisdictions.***

The Companies Act and rules made thereunder, the rules and regulations issued by SEBI and other regulatory authorities, the Memorandum of Association, and the Articles of Association govern the corporate affairs of our Company. Indian legal principles relating to these matters and the validity of corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another

jurisdiction. In accordance with the provisions of the Companies Act the voting rights of an equity shareholder in a company shall be in proportion to the share of a person in the paid-up equity share capital of that company. Further, Section 106(1) of the Companies Act states that the articles of a company may provide that no member shall exercise any voting right in respect of any shares registered in his name on which any calls or other sums presently payable by him have not been paid, or in regard to which the company has exercised any right of lien.

**16. You may be subject to Indian taxes arising out of capital gains on the sale of the Rights Equity Shares.**

Under the current Indian Income Tax provisions, all transactions of purchase and sales of securities on Indian stock exchange are subject to levy of securities transaction tax (STT) which will be collected by respective stock exchange on which the securities are transacted. Accordingly, the Indian Income Tax Act has special capital gains tax provisions for all transactions of purchase and sale of equity shares carried out on the Indian Stock Exchange. Under the current Indian Income Tax provisions, unless specifically exempted, capital gains arising from the sale of equity shares in an Indian company are generally taxable in India.

**17. Investors may be restricted in their ability to exercise pre-emptive rights under Indian law and thereby may suffer future dilution of their ownership position.**

Under the Companies Act, a company having share capital and incorporated in India must offer its holders of equity shares pre-emptive rights to subscribe and pay for a proportionate number of shares to maintain their existing ownership percentages before the issuance of any new equity shares, unless the pre-emptive rights have been waived by adoption of a special resolution by the company. However, if the law of the jurisdiction the investors are in, does not permit them to exercise their pre-emptive rights without our Company filing an offering document or registration statement with the applicable authority in such jurisdiction, the investors will be unable to exercise their pre-emptive rights unless our Company makes such a filing. If we elect not to file a registration statement, the new securities may be issued to a custodian, who may sell the securities for the investor's benefit. The value such custodian receives on the sale of such securities and the related transaction costs cannot be predicted. In addition, to the extent that the investors are unable to exercise pre-emptive rights granted in respect of the Equity Shares held by them, their proportional interest in our Company would be reduced.

## EXTERNAL RISK FACTORS

**18. Our business, results of operations and cash flows is substantially affected by prevailing economic, political and other conditions in emerging and global markets.**

The Indian economy and securities markets are influenced by economic, political and market conditions in India and globally, including adverse geopolitical conditions. We are incorporated in India, and a substantial amount of our operations are located in India and overseas. As a result, we are highly dependent on prevailing economic conditions in India and the other emerging and global markets and our results of operations and cash flows are significantly affected by factors influencing the economy in these countries. Factors that may adversely affect the economy, and hence our results of operations and cash flows, may include:

- any increase in interest rates or inflation;
- any exchange rate fluctuations;
- any scarcity of credit or other financing, resulting in an adverse impact on economic conditions and scarcity of financing for our expansions;
- prevailing income conditions among consumers and corporates;
- volatility in, and actual or perceived trends in trading activity on, the relevant market's principal stock exchange;
- changes in tax, trade, fiscal or monetary policies;
- political instability, terrorism or military conflict in the region or globally;
- occurrence of natural or man-made disasters;
- prevailing regional or global economic conditions, including in the relevant country's principal export markets;
- any downgrading of debt rating by a domestic or international rating agency;
- instability in financial markets;
- disruption of supply chain and logistics arrangements; and
- other significant regulatory or economic developments in or affecting India or the emerging and global markets.

In addition, any slowdown or perceived slowdown in the Indian economy or the economy of any emerging and global market, or in specific sectors of such economies, could adversely impact our business, results of operations and financial condition and the price of the Equity Shares.

**19. Inflation in India could have an adverse effect on our profitability and if significant, on our financial condition.**

Inflation rates in India have been volatile in recent years, and such volatility may continue in the future. India has experienced high inflation in the recent past. Increased inflation can contribute to an increase in interest rates and increased costs to our business, including increased costs of salaries, and other expenses relevant to our business.

High fluctuations in inflation rates may make it more difficult for us to accurately estimate or control our costs. Any increase in inflation in India can increase our expenses, which we may not be able to pass on to our customers, whether entirely or in part, and the same may adversely affect our business and financial condition. In particular, we might not be able to reduce our costs or increase our rates to pass the increase in costs on to our customers. In such case, our business, results of operations, cash flows and financial condition may be adversely affected.

**20. Natural calamities, climate change and health epidemics and pandemics such as COVID-19 could adversely affect the economy of countries globally and our business, financial condition and results of operations. In addition, hostilities, terrorist attacks, civil unrest and other acts of violence could adversely affect our business, results of operations and financial condition.**

Several countries have experienced natural calamities, such as earthquakes and floods in recent years. Natural calamities could have an adverse impact on the global economy which, in turn, could adversely affect our business, and may damage or destroy our borrowers' assets or projects. Any of these natural calamities could adversely affect our business, results of operations and financial condition. A number of countries in Asia, including India, as well as countries in other parts of the world, are susceptible to contagious diseases and, for example, have had confirmed cases of the highly pathogenic H7N9, H5N1 and H1N1 strains of influenza in birds and swine. In addition, the COVID-19 pandemic, had caused a worldwide health crisis and economic downturn. Any future outbreak of health epidemics may restrict the level of business activity in affected areas, which may, in turn, adversely affect our business.

**21. Changing laws, rules and regulations and legal uncertainties may adversely affect our business, prospects, results of operations and cash flows. Further, failure to comply with the existing laws and regulations applicable to our business could subject our Company to enforcement actions and penalties and otherwise harm our business.**

The regulatory environment in which we operate is subject to changes as may be notified by the government and other regulatory authorities. Any change in Indian tax laws could adversely affect our operations. The Government of India announced the Union Budget for 2025-2026, following which the Finance Bill, 2025 ("Finance Bill") was introduced in the Lok Sabha on February 1, 2025. The Finance Bill has received assent from the President of India on March 29, 2025, and has been enacted as the Finance Act, 2025. The Finance Act, 2025 has made various amendments to taxation laws in India. Unfavorable changes in or interpretations of existing, or the promulgation of new laws, rules and regulations including foreign investment laws governing our business, operations, and group structure could result in us being deemed to be in contravention of such laws or may require us to apply for additional approvals. We may incur increased costs relating to compliance with such new requirements, which may also require management time and other resources, and any failure to comply may adversely affect our business, results of operations and prospects. Uncertainty in the applicability, interpretation or implementation of any amendment to, or change in, governing law, regulation or policy, including by reason of an absence, or a limited body, of administrative or judicial precedent, may be time consuming as well as costly for us to resolve and may affect the viability of our current business or restrict our ability to grow our business in the future.

We cannot predict whether any new tax laws or regulations impacting our operations will be enacted, what the nature and impact of the specific terms of any such laws or regulations will be or whether, if at all, any laws or regulations would have an adverse effect on our business. There is no certainty on how such amendments will impact our business, operations or the industry in which we operate. In addition, unfavorable changes in or interpretations of existing, or the promulgation of new laws, rules and regulations including foreign investment laws governing our business, operations and group structure could result in us being deemed to be in contravention of such laws or may require us to apply for additional approvals. We may incur increased costs relating to compliance with such new requirements, which may also require management time and other resources, and any failure to comply may adversely affect our business, results of operations and prospects. Uncertainty in the applicability, interpretation or implementation of any amendment to, or change in, governing law, regulation or policy, including by reason of an absence, or a limited body, of administrative or judicial precedent may be time

consuming as well as costly for us to resolve and may affect the viability of our current business or restrict our ability to grow our business in the future.

**22. *We are subject to regulatory, economic, social and political uncertainties and other factors beyond our control.***

We are incorporated in India and we conduct our corporate affairs and our business in India. Our Equity Shares are listed on BSE SME. Consequently, our business, operations, financial performance and the market price of our Equity Shares will be affected by interest rates, government policies, taxation, social and ethnic instability and other political and economic developments affecting India.

Factors that may adversely affect the Indian economy, and hence our results of operations may include:

- any exchange rate fluctuations, the imposition of currency controls and restrictions on the right to convert or repatriate currency or export assets;
- any scarcity of credit or other financing in India, resulting in an adverse effect on economic conditions in India and scarcity of financing for our expansions;
- prevailing income conditions among Indian customers and Indian corporations;
- epidemic or any other public health in India or in countries in the region or globally, including in India's various neighbouring countries;
- hostile or war like situations with the neighbouring countries;
- macroeconomic factors and central bank regulation, including in relation to interest rates movements which may in turn adversely impact our access to capital and increase our borrowing costs;
- volatility in, and actual or perceived trends in trading activity on, India's principal stock exchange;
- decline in India's foreign exchange reserves which may affect liquidity in the Indian economy;
- downgrading of India's sovereign debt rating by rating agencies; and
- difficulty in developing any necessary partnerships with local businesses on commercially acceptable terms and/or a timely basis.

**23. *In the event we undertake future acquisitions, mergers or similar corporate actions, we may potentially be affected by competition law in India and any adverse application or interpretation of the Competition Act could in turn adversely affect our business, results of operations and financial condition.***

The Competition Act, 2002 ("**Competition Act**") was enacted for the purpose of preventing practices that have or are likely to have an adverse effect on competition in India and has mandated the Competition Commission of India to prevent such practices. Under the Competition Act, any arrangement, understanding or action, whether formal or informal, which causes or is likely to cause an appreciable adverse effect on competition ("**AAEC**") is void and attracts substantial penalties.

Further, any agreement among competitors which, directly or indirectly, involves determination of purchase or sale prices, limits or controls production, or shares the market by way of geographical area or number of customers in the relevant market is presumed to have an appreciable adverse effect in the relevant market in India and shall be void. The Competition Act also prohibits abuse of a dominant position by any enterprise. The Competition Commission of India (Procedure in regard to the transaction of business relating to combinations) Regulations ("**Combination Regulations**") require acquisitions of shares, voting rights, assets or control or mergers or amalgamations that cross the prescribed asset and turnover based thresholds to be mandatorily notified to, and pre-approved by, the Competition Commission of India. The Competition Act aims to, among other things, prohibit all agreements and transactions which may have an appreciable adverse effect in India. Consequently, all agreements entered into by us in future could be within the purview of the Competition Act. Further, the Competition Commission of India has extra-territorial powers and can investigate any agreements, abusive conduct or combination occurring outside of India if such agreement, conduct or combination has an appreciable adverse effect in India.

The Competition (Amendment) Act, 2023 ("**Competition Amendment Act**") was notified on April 11, 2023, which amends the Competition Act and gives the CCI additional powers to prevent practices that harm competition and the interests of consumers. These amendments include the introduction of deal value thresholds for assessing whether a merger or acquisition qualifies as a "combination", expedited merger review timelines, codification of the lowest standard of "control" and enhanced penalties for providing false information or a failure to provide material information. Such amendment to the Competition Act will result in additional costs for compliance, which in turn may adversely affect our business, results of operations, cash flows and prospect.

**24. *Companies operating in India are subject to a variety of taxes and surcharges.***

Tax and other levies imposed by the central and state governments in India that affect our tax liability include central and state taxes and other levies, income tax, value added tax, turnover tax, service tax, stamp duty, tax on dividends and other special taxes and surcharges which are introduced on a temporary or permanent basis from time to time. Moreover, the central and state tax scheme in India is extensive and subject to change from time to time. The central or state government may in the future increase the corporate income tax it imposes. Any such future increases or amendments may affect the overall tax efficiency of companies operating in India and may result in significant additional taxes becoming payable. Additional tax exposure could adversely affect our business, cash flows and results of operations.

**25. *Fluctuation of the Rupee against foreign currencies may have an adverse effect on the price of the Equity Shares.***

Any adverse movement in currency exchange rates during the time that it takes to undertake such conversion may reduce the net dividend to foreign investors. In addition, any adverse movement in currency exchange rates during a delay in repatriating outside India the proceeds from a sale of Equity Shares, for example, because of a delay in regulatory approvals that may be required for the sale of Equity Shares may reduce the proceeds received by Equity shareholders. For example, the exchange rate between the Rupee and the U.S. Dollar has fluctuated substantially in recent years and may continue to fluctuate substantially in the future, which may have an adverse effect on the trading price of our Equity Shares and returns on our Equity Shares, independent of our operating results.

**26. *Rights of shareholders under Indian laws may differ to those under the laws of other jurisdictions.***

Indian laws and legal principles related to corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. Shareholders' rights under Indian law, including in relation to class actions, may not be as extensive as shareholders' rights under the laws of other countries or jurisdictions. Investors may face challenges in asserting their rights as shareholder in an Indian company than as a shareholder of an entity in another jurisdiction.

Our Company proposes to deploy the Net Proceeds towards the objects as described herein during FY 2026–27. The fund requirements, proposed deployment of funds and the intended use of the Net Proceeds set out above is based on our current business plan, internal management estimates, current circumstances of our business, prevailing market conditions and other commercial considerations. However, these fund requirements and proposed deployment of Net Proceeds have not been appraised by any bank or financial institution. The major working capital are required for procuring bullion, maintaining inventories, advance to suppliers and Sundry Debtors etc. as the money gets blocked in them.

Based on our management estimations, and for other strategic, business and corporate purposes, we require additional working capital for our future growth requirements. Our working capital requirement has been increased from ₹2,437.52 lakhs in FY 2023-24 to ₹5,535.40 lakhs in FY 2025-26 due to increase in revenue from operations of ₹4,335.11 lakhs in FY 2023-24 to ₹11,416.12 lakhs in FY 2025-26.

Our working capital requirement is expected to be ₹7,758.82 lakhs for FY 2026-27 based on our management estimation as per the current market demand.

Our Company proposed to utilise upto ₹1,353.23 lakhs of the Net Proceeds towards funding the working capital requirements of our Company in the ordinary course of business and the balance will be met from internal accruals and borrowings at an appropriate time as per the requirement. As on March 31, 2026, the aggregate amount sanctioned by the banks to our Company to meet working capital requirement is ₹ 1,950 lakhs consists of fund based working capital facilities.

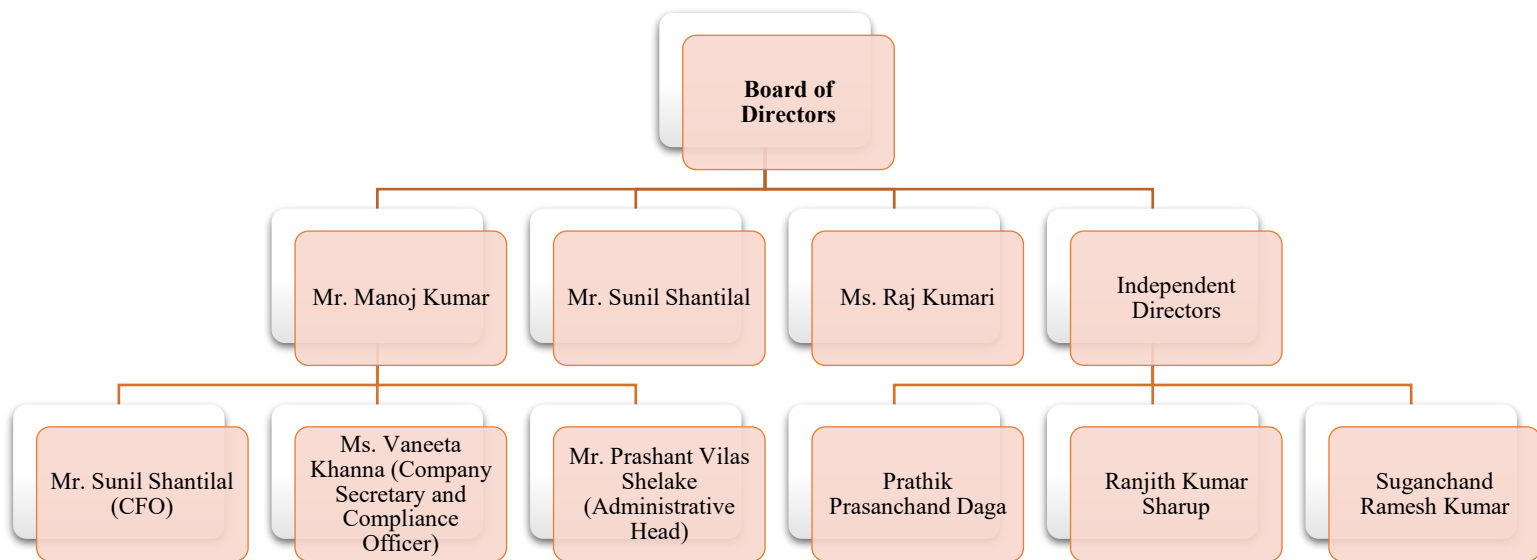

*Procedure for Applications by FPIs*

In terms of applicable FEMA Rules and the SEBI FPI Regulations, investments by FPIs in the Equity Shares is subject to certain limits, i.e., the individual holding of an FPI (including its investor group (which means multiple entities registered as foreign portfolio investors and directly and indirectly having common ownership of more than 50% of common control)) shall be below 10% of our post-Issue Equity Share capital. In case the total holding of an FPI or investor group increases beyond 10% of the total paid-up Equity Share capital of our Company, on a fully diluted basis or 10% or more of the paid-up value of any series of debentures or preference shares or share warrants that may be issued by our Company, the total investment made by the FPI or investor group will be re-classified as FDI subject to the conditions as specified by SEBI and RBI in this regard. Further, the aggregate limit of all FPIs investments is up to the sectoral cap applicable to the sector in which our Company operates.

FPIs are permitted to participate in this Issue subject to compliance with conditions and restrictions which may be specified by the Government from time to time. FPIs who wish to participate in the Issue are advised to use the Application Form for non-residents. Subject to compliance with all applicable Indian laws, rules, regulations, guidelines and approvals in terms of Regulation 21 of the SEBI FPI Regulations, an FPI may issue, subscribe to or otherwise deal in offshore derivative instruments (as defined under the SEBI FPI Regulations as any instrument, by whatever name called, which is issued overseas by an FPI against securities held by it that are listed or proposed to be listed on any recognised stock exchange in India, as its underlying) directly or indirectly, only in the event (i) such

offshore derivative instruments are issued only to persons registered as Category I FPI under the SEBI FPI Regulations; (ii) such offshore derivative instruments are issued only to persons who are eligible for registration as Category I FPIs (where an entity has an investment manager who is from the Financial Action Task Force member country, the investment manager shall not be required to be registered as a Category I FPI); (iii) such offshore derivative instruments are issued after compliance with 'know your client' norms; and (iv) compliance with other conditions as may be prescribed by SEBI.

An FPI issuing offshore derivative instruments is also required to ensure that any transfer of offshore derivative instruments issued by or on its behalf, is carried out subject to inter alia the following conditions:

- (a) such offshore derivative instruments are transferred only to persons in accordance with the SEBI FPI Regulations; and
- (b) prior consent of the FPI is obtained for such transfer, except when the persons to whom the offshore derivative instruments are to be transferred to are pre – approved by the FPI.

#### ***Procedure for Applications by AIFs, FVCIs, VCFs and FDI route***

The SEBI VCF Regulations and the SEBI FVCI Regulations prescribe, among other things, the investment restrictions on VCFs and FVCIs registered with SEBI. Further, the SEBI AIF Regulations prescribe, among other things, the investment restrictions on AIFs.

As per the SEBI VCF Regulations and SEBI FVCI Regulations, VCFs and FVCIs are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by VCFs or FVCIs will not be accepted in this Issue. Further, venture capital funds registered as Category I AIFs, as defined in the SEBI AIF Regulations, are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by venture capital funds registered as category I AIFs, as defined in the SEBI AIF Regulations, will not be accepted in this Issue. Other categories of AIFs are permitted to apply in this Issue subject to compliance with the SEBI AIF Regulations. Such AIFs having bank accounts with SCSBs that are providing ASBA in cities / centres where such AIFs are located are mandatorily required to make use of the ASBA facility. Otherwise, applications of such AIFs are liable for rejection.

#### ***Procedure for Applications by NRIs***

Investments by NRIs are governed by the FEMA Rules. Applications will not be accepted from NRIs that are ineligible to participate in this Issue under applicable securities laws.

As per the FEMA Rules, an NRI or Overseas Citizen of India (“OCI”) may purchase or sell capital instruments of a listed Indian company on repatriation basis, on a recognised stock exchange in India, subject to the conditions, inter alia, that the total holding by any individual NRI or OCI will not exceed 5% of the total paid-up equity capital on a fully diluted basis or should not exceed 5% of the paid-up value of each series of debentures or preference shares or share warrants issued by an Indian company and the total holdings of all NRIs and OCIs put together will not exceed 10% of the total paid-up equity capital on a fully diluted basis or shall not exceed 10% of the paid-up value of each series of debentures or preference shares or share warrants. The aggregate ceiling of 10% may be raised to 24%, if a special resolution to that effect is passed by the general body of the Indian company.

Further, in accordance with press note 3 of 2020, the FDI Policy has been amended to state that all investments by entities incorporated in a country which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country (“**Restricted Investors**”), will require prior approval of the Government of India. It is not clear from the press note whether or not an issue of the Rights Equity Shares to Restricted Investors will also require prior approval of the Government of India and each Investor should seek independent legal advice about its ability to participate in the Issue. In the event such prior approval has been obtained, the Investor shall intimate our Company and the Registrar about such approval within the Issue Period.

#### ***Procedure for Applications by Mutual Funds***

A separate application can be made in respect of each scheme of an Indian mutual fund registered with SEBI and such applications shall not be treated as multiple applications. The applications made by asset management companies or custodians of a mutual fund should clearly indicate the name of the concerned scheme for which the application is being made.

No Mutual Fund scheme shall invest more than 10% of its net asset value in equity shares or equity related instruments of any single company provided that the limit of 10% shall not be applicable for investments in case of index funds

or exchange traded funded or sector or industry specific schemes. No Mutual Fund under all its schemes should own more than 10% of any company's paid-up share capital carrying voting rights.

### ***Procedure for Applications by Systemically Important Non-Banking Financial Companies ("NBFC-SI")***

In case of an application made by NBFC-SI registered with RBI, (a) the certificate of registration issued by RBI under Section 45IA of RBI Act, 1934 and (b) net worth certificate from its statutory auditors or any independent chartered accountant based on the last audited financial statements is required to be attached to the application.

### ***Last date for Application***

The last date for submission of the duly filled in the Application Form or a plain paper Application is September 29, 2026, i.e., Issue Closing Date. Our Board or any committee thereof may extend the said date for such period as it may determine from time to time, subject to the Issue Period not exceeding 30 days from the Issue Opening Date (inclusive of the Issue Opening Date).

### **• Fractional Entitlements**

- **Ranking**

The Rights Equity Shares to be issued and Allotted pursuant to this Issue shall be subject to the provisions of this Letter of Offer, the Rights Entitlement Letter, the Application Form, and the Memorandum of Association and the Articles of Association, the provisions of the Companies Act, 2013, FEMA, the SEBI ICDR Regulations, the SEBI LODR Regulations, and the guidelines, notifications and regulations issued by SEBI, the Government of India and other statutory and regulatory authorities from time to time, the terms of the Listing Agreements entered into by our Company with the Stock Exchange and the terms and conditions as stipulated in the Allotment advice. ## **VIII. GENERAL TERMS OF THE ISSUE**

- ***Market Lot***

- ***Joint Holders***

Where two or more persons are registered as the holders of any Equity Shares, they shall be deemed to hold the same as the joint holders with the benefit of survivorship subject to the provisions contained in our Articles of Association. In case of Equity Shares held by joint holders, the Application submitted in physical mode to the Designated Branch of the SCSBs would be required to be signed by all the joint holders (in the same order as appearing in the records of the Depository) to be considered as valid for allotment of Equity Shares offered in this Issue.

- ***Nomination***

All notices to the Eligible Equity Shareholders required to be given by our Company shall be published in one English language national daily newspaper with wide circulation, one Hindi language national daily newspaper with wide circulation and one Kannada language daily newspaper with wide circulation (Kannada being the regional language of Karnataka, where our Registered Office is situated).

- ***Offer to Non-Resident Eligible Equity Shareholders/Investors***

Further, where the fraud involves an amount less than ₹10 Lakhs or 1% of the turnover of the company, whichever is lower, and does not involve public interest, any person guilty of such fraud shall be punishable with imprisonment for a term which may extend to five years or with fine which may extend to ₹50 Lakhs or with both.

## RESTRICTIONS ON FOREIGN OWNERSHIP OF INDIAN SECURITIES

There are two routes through which foreign investors may invest in India. One is the “automatic route”, where no government approval is required under Indian foreign exchange laws to make an investment as long as it is within prescribed thresholds for the relevant sector. The other route is the “government route”, where an approval is required under foreign exchange laws from the relevant industry regulator, prior to the investment.

Foreign investment in Indian securities is regulated through the Industrial Policy, 1991, of the Government of India and FEMA. While the Industrial Policy, 1991, of the Government of India, prescribes the limits and the conditions subject to which foreign investment can be made in different sectors of the Indian economy, FEMA regulates the precise manner in which such investment may be made. The Union Cabinet, as provided in the Cabinet Press Release dated May 24, 2017, has given its approval for phasing out the FIPB. Under the Industrial Policy, 1991, unless specifically restricted, foreign investment is freely permitted in all sectors of the Indian economy up to any extent and without any prior approvals, but the foreign investor is required to follow certain prescribed procedures for making such investment. Accordingly, the process for foreign direct investment (“FDI”) and approval from the Government of India will now be handled by the concerned ministries or departments, in consultation with the Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India (formerly known as the Department of Industrial Policy and Promotion) (“DPIIT”), Ministry of Finance, Department of Economic Affairs, FIPB section, through a memorandum dated June 5, 2017, has notified the specific ministries handling relevant sectors.

The Government has, from time to time, made policy pronouncements on FDI through press notes and press releases. The DPIIT issued the Consolidated FDI Policy Circular of 2020 (“FDI Policy”) by way of circular bearing number DPIIT file number 5(2)/2020-FDI Policy dated October 15, 2020, which with effect from October 15, 2020, consolidates and supersedes all previous press notes, press releases and clarifications on FDI issued by the DPIIT that were in force and effect as on October 15, 2020. The Government of India has from time to time made policy pronouncements on FDI through press notes and press releases which are notified by RBI as amendments to FEMA. In case of any conflict between FEMA and such policy pronouncements, FEMA prevails.

As per Rule 7 of the Foreign Exchange Management (Non-debt Instruments) Rules, 2019, the RBI has given general permission to Indian companies to issue rights securities to non-resident shareholders including additional rights securities. Further, as per the Master Direction on Foreign Investment in India dated January 4, 2018 issued by the RBI, non-residents may, inter alia, (i) subscribe for additional securities over and above their rights entitlement; (ii) renounce the securities offered to them either in full or part thereof in favour of a person named by them; or (iii) apply for the securities renounced in their favour. Applications received from NRIs and non-residents for allotment of Rights Equity Shares shall be inter alia, subject to the conditions imposed from time to time by the RBI under the FEMA in the matter of refund of Application Money, Allotment of Rights Equity Shares and issue of Allotment advice. ## RESTRICTIONS ON PURCHASES AND RESALES
